- Two additional copies for EACH defendant and one copy for the plaintiff listed on the **Complaint for Eviction** and any other paperwork being filed at that time.
- Filing fee

#### TO REQUEST THE PROPERTY BE RETURNED TO PLAINTIFF, YOU WILL NEED:

- Completed Practipe for Writ of Restitution.
- Filing fee

*Note:* Once the **Writ of Restitution** is prepared by the clerk, it is then forwarded to the Oakwood Police Department for service. The police department will call the property owner or owner's counsel listed as point of contact on the **Praecipe for Writ of Restitution.** This process is solely enforced by the police department. Please do not contact the clerks regarding the move-out status.
